**APPROVING THE MEMBERSHIP OF THE BOARD OF INVESTMENTS,
COOPERATIVES DEVELOPMENT AUTHORITY 7, PHILIPPINE
ECONOMIC ZONE AUTHORITY 7 AND SECURITIES AND
EXCHANGE COMMISSION 7 IN THE CENTRAL VISAYAS
REGIONAL STATISTICS COMMITTEE (CV-RSC)**

WHEREAS, Republic Act No. 10625 otherwise known as the Philippine Statistical Act of 2013 created the Philippine Statistics Authority (PSA) Board as the highest policy-making body on statistical matters, and mandates the PSA to prescribe appropriate statistical frameworks and establish mechanisms for statistical coordination at the regional and local levels;

WHEREAS, PSA Board Resolution No. 03, Series of 2017 established the Regional Statistics Committees (RSCs) to provide guidance and direction to regional/local statistical development activities, and serve as policy-making body on statistical issues and matters at the regional levels;

WHEREAS, PSA Board Resolution No. 05, series of 2015 provides for representation from Provincial Planning and Development Offices (PPDOs), Academe/State Universities/Colleges (SUCs), and the Private Sector in the RSC, who shall be appointed by the RSC Chair for a term of three (3) years, with possible reappointment;

WHEREAS, the same Resolution likewise allows the RSC to modify its composition to provide flexibility in its operations;

WHEREAS, the membership of the Board of Investments (BOI) 7, Cooperatives Development Authority (CDC) 7, Philippine Economic Zone Authority (PEZA) 7 and Securities and Exchange Commission (SEC) 7 in the CV-RSC will benefit the Committee, particularly in its function to formulate statistical policies designed to resolve local statistical issues and recommend workable schemes towards the improvement of local level statistics.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, to approve the membership of the BOI 7, CDA 7, PEZA 7 and SEC 7 in the CV-RSC.

RESOLVED FURTHER that copies of this resolution shall be provided to the aforementioned agencies.
