

During the Opening Ceremony of the 34th Civil Registration Month (CRM) on 01 February 2024, a short Opening Program and Lecture on Civil Registration Updates and New Memorandum Circulars was conducted in PSA Negros Oriental Provincial Office. The lecture includes discussion of Memorandum Circular No. 2023-23 or Process for British Nationals Who Wish to Obtain Marriage License in the Philippines, which was discussed by ROI Joana I. Ymalav. Another was Memorandum Circular No. 2023-08 or Processing of Copy Issuance of Civil **Registry Documents and Certifications** for Free as Pro Bono Transactions discussed by ROII Jocelyn T. Vera Cruz.

Meanwhile, ROI Crislor V. Flores tackled on Memorandum Circular No. 2023-14 or the Amendment of the Implementing Rules and Regulations of Republic Act No. 9255. Lastly, Memorandum Circular No. 2023-21 or Renaming Philsys Birth Registration Assistance Project to Birth Registration Assistance Project (BRAP) and its updates were presented by Ms. April Joy M. Nario, Birth Registration This activity aims to educate the PSA Negros Oriental personnel and on-thejob trainees on the new updates on Civil Registration matters.

DeCAP Feedbacking to the LCRO personnel aims to have a uniform understanding of the documentary requirements and procedures of DeCAP and improve existing processes.

Also, collective experiences and strategies during the data processing of Visit 1 data were shared. On the second day, hands-on exercises on the installation of the DPS and cleaning of the data files were given. Further, SA Chiong emphasizes to the processors to be keen and truthful on their duties.

Data processing involves data consistency, completeness check, Geoid validation, data matching of Visit 1 data and January 2024 LFS, in-kind vs sources and tabulation. The training was held at the Provincial office of Negros Oriental on February 26-27, 2024. CSS Fortuito gave his message to the team to work hard for the common good. He also congratulated the team for the successful conduct of the January 2024 LFS/ FIES V2 enumeration. Seven data processors were hired for the 2023 FIES Visit 2 Data Processing. The hired processors were the team supervisors and statistical researchers of the January 2024 LFS/ 2023 FIES V2 enumeration with commendable performances.
